TERMS

CHILD TAX CREDIT

Families with incomes of up to £58,000 (or £68,000 if there is a child at least one year old) are eligible. This is paid directly into the bank account of the main carer. We have the facilities for you to apply on line within the nursery or alternatively contact the Inland Revenue on 0845 300 3900 or go to www.taxcredits.inlandrevenue.gov.uk

CHILDCARE ELEMENT OF WORKING TAX CREDIT

This can pay up to 70% of childcare costs.

*** FUNDING FOR 3 – 5 YEAR OLDS**

Your child becomes eligible for a grant funded place at the start of the term after their third birthday. This means they will be entitled to Free Childcare for 12.5 hours per week. (Term time)
